Dear Ms. Teague:

Thank you for your recent memo containing the audit of Mid-year, Semi-Annual Report for Committee to Elect DeJuana Bigelow. Attached you will find the amended report. This letter and amended report serve as the reply to "Campaign Report Discrepancies Reply Required" dated August 10, 2023.

The reason the original report showed a different starting balance than the last report that was filed (2021 Year-end, Semi-Annual) was due to a few contributions and expenses that occurred during the calendar year 2022. In January 2022, Ms. Bigelow filed CRO-3600 to indicate they would be under threshold during the next election cycle. Because the CRO-3600 had been filed, no campaign finance reports were submitted during 2022. The bank account remained open and there were debits of \$305.15 and credits of \$175. The balance at 12/31/2021 was correctly reported as \$366.34. During 2022, debits and credits brought the balance to \$236.19 which was originally our starting balance on the Mid-Year report. ($366.34 + 175 - 305.15 = 236.19$). In May of 2023, the candidate submitted the CRO-3600 to indicate they would no longer be under threshold

I asked the SBOE how to handle this, and this is the response:

"When a committee withdraws from the Threshold, they are required to file the next report in the cycle. This report should start at the beginning of the election cycle, and so you will need to amend the 2023 Mid-Year Semi Annual to show a start date of 01/01/2022. This will then pick up the transactions that occurred in 2022 as well as the first 6 months of 2023."

I have amended the Mid-year, Semi-Annual to show a starting date of 1/1/2022. The report now includes all the missing contributions and expenses not contained in the original report. There are additional donations of \$175 from Lisa Marinis, and additional expenditures of \$305.15. The ending balance is still the same at \$1043.96. Note the election cycle begins at 2022.

I have also reported the Employer's information that was missing.




